

## Qualifications for the FM GROUP International Motivational Training in 2015 in Wroclaw

Below you will find the eligibility criteria for the International Motivational Training to be held in 2015 in Wroclaw.

We will invite to this unique event those Business Partners, who from April 1, 2014 to February 28, 2015 (**11 months**) will have met the conditions specified below.

This time we have changed the way of granting invitations so that each Business Partner, could, through their work, get more invitations for themselves and persons they cooperate with.

**Generating at least 50 personal points in every month of qualifications is an obligatory condition to be granted invitations.**

To facilitate the understanding of the qualifications we are presenting the number of invitations the Business Partners will receive for having reached individual Effectiveness Levels.

### **GOLDEN MANGOLIAS (21%)**

#### **2 DOUBLE INVITATIONS**

are granted to the Business Partners who will have achieved the Golden Magnolia effectiveness level (21%) at least 7 times in the qualification period (from April 1, 2014 to February 28, 2015), whereas in each of these 7 months the main downline can not constitute more than 60% of the total points turnover (the so called 60/40 principle).

### **PEARL ORCHIDS**

#### **5 DOUBLE INVITATIONS**

are granted to the Business Partners who will have achieved the **Pearl Orchid** effectiveness level **at least 7 times** in the qualification period (from April 1, 2014 to February 28, 2015) and will have generated **at least 14 qualification points** in each of these 7 months. Qualification points are granted for the development of a structure (see the table below).

#### **4 DOUBLE INVITATIONS**

are granted to the Business Partners who will have achieved the **Pearl Orchid** effectiveness level **at least 7 times** in the qualification period (from April 1, 2014 to February 28, 2015) and will have generated **at least 10,50 qualification points** in each of these 7 months. Qualification points are granted for the development of a structure (see the table below).

#### **3 DOUBLE INVITATIONS**

are granted to the Business Partners who will have achieved the **Pearl Orchid** effectiveness level **at least 7 times** in the qualification period (from April 1, 2014 to February 28, 2015) and will have generated **at least 6 qualification points** in each of these 7 months. Qualification points are granted for the development of a structure (see the table below).

## AMARANTH ORCHIDS

### 9 DOUBLE INVITATIONS

are granted to the Business Partners who will have achieved the effectiveness level of an **Amaranth Orchid at least 7 times** in the qualification period (from April 1, 2014 to February 28, 2015) and will have generated **at least 18 qualification points** in each of these 7 months. Qualification points are granted for the development of a structure (see the table below).

### 8 DOUBLE INVITATIONS

are granted to the Business Partners who will have achieved the effectiveness level of an **Amaranth Orchid at least 7 times** in the qualification period (from April 1, 2014 to February 28, 2015) and will have generated **at least 14 qualification points** in each of these 7 months. Qualification points are granted for the development of a structure (see the table below).

### 7 DOUBLE INVITATIONS

are granted to the Business Partners who will have achieved the effectiveness level of an **Amaranth Orchid at least 7 times** in the qualification period (from April 1, 2014 to February 28, 2015) and will have generated **at least 9 qualification points** in each of these 7 months. Qualification points are granted for the development of a structure (see the table below).

## GOLDEN ORCHIDS

### 12 DOUBLE INVITATIONS

are granted to the Business Partners who will have achieved the effectiveness level of a **Golden Orchid at least 7 times** in the qualification period (from April 1, 2014 to February 28, 2015) and will have generated **at least 20,50 qualification points** in each of these 7 months. Qualification points are granted for the development of a structure (see the table below).

### 11 DOUBLE INVITATIONS

are granted to the Business Partners who will have achieved the effectiveness level of a **Golden Orchid at least 7 times** in the qualification period (from April 1, 2014 to February 28, 2015) and will have generated **at least 16,50 qualification points** in each of these 7 months. Qualification points are granted for the development of a structure (see the table below).

### 10 DOUBLE INVITATIONS

are granted to the Business Partners who will have achieved the effectiveness level of a **Golden Orchid at least 7 times** in the qualification period (from April 1, 2014 to February 28, 2015) and will have generated **at least 12 qualification points** in each of these 7 months. Qualification points are granted for the development of a structure (see the table below).

## **DIAMOND ORCHIDS**

### 15 DOUBLE INVITATIONS

are granted to the Business Partners who will have achieved the effectiveness level of a **Diamond Orchid at least 7 times** in the qualification period (from April 1, 2014 to February 28, 2015) and will have generated **at least 30 qualification points** in each of these 7 months. Qualification points are granted for the development of a structure (see the table below).

### 14 DOUBLE INVITATIONS

are granted to the Business Partners who will have achieved the effectiveness level of a **Diamond Orchid at least 7 times** in the qualification period (from April 1, 2014 to February 28, 2015) and will have generated **at least 23 qualification points** in each of these 7 months. Qualification points are granted for the development of a structure (see the table below).

### 13 DOUBLE INVITATIONS

are granted to the Business Partners who will have achieved the effectiveness level of a **Diamond Orchid at least 7 times** in the qualification period (from April 1, 2014 to February 28, 2015) and will have generated **at least 20 qualification points** in each of these 7 months. Qualification points are granted for the development of a structure (see the table below).

#### 16 DOUBLE INVITATIONS

are granted to the Business Partners who will have achieved any effectiveness level in Marketing Plan 3 **at least 3 times** in the qualification period (from April 1, 2014 to February 28, 2015).
